ABOR to Hold Committee, Special Board Meetings

WHAT:

The Arizona Board of Regents will convene during a special board and committee meetings on Thursday, May 31, at Arizona State University. Agenda items for committees scheduled to meet include the following:

- <u>Audit Committee</u> meeting agenda items include fiscal year 2019 audit plans for ASU, Northern Arizona University and the University of Arizona, and an internal audit benchmarking presentation.
- Academic and Student Affairs Committee meeting agenda items include the 2018
 Arizona Teachers Academy Annual Report; the fifth in a five-part review series on
 general education quality assurance; and new academic programs for the UA.
- Research, Innovation and Impact Committee meeting agenda items include the fiscal year 2017 Annual Research Report; Technology and Research Initiative Fund Regents' Innovation Fund proposals; an NAU Allied Health Programs update; and an update on Banner University Medical Center finances.
- <u>Business and Finance Committee</u> meeting agenda items include fiscal year 2019 budgets for ASU, NAU, UA and the ABOR office; land exchanges between ASU and the City of Tempe; and UA Tech Parks at The Bridges master plan and development update.

A <u>special board meeting</u> will follow committee meetings with the board reviewing and possibly approving proposed amendments to the multiple-year employment contracts regarding increases to base salaries for ASU President Michael Crow, NAU President Rita Cheng and UA President Robert Robbins.
